On 10/23/10 at 0859 hours, I was dispatched to E Guadalupe Rd and S Price Rd in reference to criminal damage. Upon arrival I spoke with Donald R. Sanders who stated he has a company called Jet Media and he makes signs. He posted some signs on either side of a Harry Mitchell political sign. The signs are against Mitchell, one sign stated, "Mitchell a part of the problem since 2006." After Sanders posted the signs he traveled west on E Guadalupe Rd for a bit before deciding to turn around to check on the signs. Sanders has been finding his signs ripped into pieces or missing. Sanders stated as he approached the area where the signs were he noticed an older white male, later identified as James Arnold Lucas, kicking one sign with his foot. Sanders stopped to confront Lucas. As he got out of his vehicle he observed Lucas take the other sign out of the ground and throw it on the ground. Sanders stated he told Lucas to put his sign back in the ground. Sanders and Lucas argued back and forth for while before Lucas replaced the sign.

Lucas was still on scene, sitting in front of 2160 E Guadalupe Rd. Lucas stated he was riding his bicycle westbound on E Guadalupe Rd when he noticed the signs. He felt the signs were positioned as to purposely block the Harry Mitchell sign and he did not feel that was right. Lucas stated he was holding his bicycle so he had to use his foot to push the sign down so people could have a clear view of the Harry Mitchell sign.

Sanders' signs were not blocking the Harry Mitchell sign. They were placed on either side of the Harry Mitchell sign not in front. Sanders is willing to aid in prosecution. Lucas was cited in lieu of detention. He was cited and released. Photos were taken of the signs and impounded as evidence at the Hardy Station at 8201 S Hardy Dr.
